## Regulation for space assignment

- The assignment of the spaces complies with the company agreement "company related daycre center Xkids".
- Application before the birth of the child is not possible. Applications can only be accepted after the end of the legar maternal leave.
- Returnees from other countries, Expatriate Inbounds can apply with the date of relocation, new employees with the beginning date of their employment.
- There is only one waiting list which is managed by the operator of the Kinderzentren Kunterbunt gGmbH.
- When children have reached the age of 2.5 or 5 years, the application is removed from the day nursery or day care waiting lists.
- Parents' obligation to cooperate: Twice a year within a 2-week period, parents must confirm if they want to remain on the waiting list. If there is no confirmation, the child will be removed from the waiting list. (01 to 14 April and 01 to 15 Oct. as confirmation time periods)
- A private telephone number and e-mail are needed so that we can reach you to offer you a place. If there is no response within one week, the space will be offered to another applicant. (Parents will be notified of the available space both via e-mail and mobile phone.)
- The assignment of spaces without vacancies has priority. For this reason, an earlier start date\* could be offered to you. If this is not taken, the place will be given to another child.
  - \* a) Day nursery: up to 6 months prior to desired care date but not prior to minimum day nursery age b) Kindergarten: up to 6 months prior to desired care date but not prior to an age of 2 years and 9 months
- If a contract has been offered, parents have to report, if they are no longer interested in this space.
- Inclusion of disabled children: inclusion of disabled children is decided on a case-by-case basis. Special mention must be made by the parents when applying for place for the child.
- Reduction of hours only possible after 1 year at the earliest, increase is possible after consultation with day care management.
- If the employment contract between the parents and LANXESS should no longer exist, the accommodation of the child at the nursery automatically terminates with the end of the nursery year.
